Currently there is a grant that focuses on mental health. Elaine is working on locating/purchasing a meeting space and looking for Native mentors at BSU--specifically young men. Also looking for someone trained in SEL (Social Emotional Learning). VES is getting a kiln, which needs to be wired.

- 6.4.1 Release Time for Religious Events & Accommodations. There is some question as to the intent behind phrases such as "observe holidays."
- 6.1 Grading and Graduation Policy: Reflects current processes that were added to the student handbook. Percentages and credit totals were adjusted prior to the 2023-2024 school year. Section VI on Credit Recovery needs to be adjusted to clarify HS/MS requirements for moving to a higher level. Perhaps some of the wording can be moved up to section III on Academics. The percentages are also incorrect.

Section removed from Grading and Graduation requirements as we review how to adjust the wording. This policy needs to be revisited during the summer months so it can be adjusted in the upcoming student handbook.

- 4.1.3 Criminal Background Checks Policy. There are suggested edits by Osprey Wilds for the sake of clarification. What is the VES policy of disposal for this paperwork? The policy states that volunteers must pay for their own background checks. We need to clarify what is necessary. Ryan and Jess adjusted the wording.
- 6.11 E-Learning Day Policy. Wording was adjusted to fit VES circumstances.
